Road Closure and Dedication Removal (Erickson Road to Island Highway)

Bylaw No. 3569, 2015

ADOPTED May 11, 2015

PURPOSE

Pursuant to the provisions in the *Community Charter* in relation to establishing and closing highways, Council may, by bylaw, close a highway, or a portion of it, to traffic and remove the dedication of a highway.

The Council of the City of Campbell River enacts as follows:

PART 1: Title

1.0 This bylaw may be cited for all purposes as “Road Closure and Dedication Removal Bylaw No. 3569, 2015.” (Erickson Road to Island Highway)

PART 2: Road Closure and Dedication Removal

- 2.0** That the portion of Lot 3, Section 18, Township 1, Comox District, Plan EPP6409, shown as Road to be Closed on Reference Plan EPP40649 marked as Schedule “A” attached hereto and forming part of this bylaw, is hereby closed and stopped up to traffic of all kinds.
- 2.1** The Highway Dedication of the parcel described in Section 2 is removed.
- 2.2** This Bylaw shall take effect upon the adoption thereof.


