The Vancouver Island Motorsports Association (VIMSA) has proposed a motorsports facility on city-owned lands adjacent to the Campbell River Airport (YBL). To facilitate the proposal, the applicant is seeking to amend the Official Community Plan Proposed Land Use designation of the property from Business and Industrial Service Centre Designation and rezone a portion of the City-owned property to add the use of a motorsports facility in the A-1 Zone. With upcoming Federal legalization of cannabis in Canada, the City of Campbell River proposes to update municipal legislation to accommodate this change.

The City will hold a Public Meeting regarding the proposed Bylaws:

- **Business License Amendment Bylaw 3704, 2018 to control how cannabis businesses will operate;**
- **Planning Procedures Amendment Bylaw 3705, 2018 to control where cannabis retail stores can be located;**
- **Municipal Smoking Amendment Bylaw 3707, 2018 to restrict where cannabis can be consumed;**
- **Parks Control Amendment Bylaw 3708, 2018 to restrict where cannabis can be consumed**

Pursuant to the Local Government Act, a Public Hearing will be held regarding the proposed Bylaw:

- **Zoning Amendment Bylaw 3703, 2018 to control where cannabis retail stores can be located.**
