



# APPLICATION TO VOTE BY MAIL

## Instructions:

1. Complete this 'Application to Vote by Mail' form and either mail, fax (250-286-5760), email ([front.reception@campbellriver.ca](mailto:front.reception@campbellriver.ca)) or deliver it to Campbell River City Hall, 301 St. Ann's Road, Campbell River, BC, V9W 4C7 by **October 2, 2018**.
2. If your application is filled out correctly, the City of Campbell River will send you a mail ballot package following the official Declaration of the Election.
3. The completed mail ballot package **MUST** be received at Campbell River City Hall no later than 4:30 pm on Friday, October 19, 2018 or have it delivered to the Presiding Election Official at the Campbell River Community Center voting place located at 401 – 11<sup>th</sup> Avenue between 8:00 am and 8:00 pm Saturday, October 20, 2018.

Request that I receive a ballot to vote by mail, under the provisions of Section 100 of the *Local Government Act*, in the General Local Election to be held on Saturday, October 20, 2018. I hereby declare that I am:

- 18 years of age or older on October 20, 2018; **AND**
- A Canadian citizen; **AND**
- A resident of the City of Campbell River for at least the past 30 days OR a non-resident owner of real property in the City of Campbell River for at least the past 30 days; **AND**
- A resident of BC for at least the past 6 months; **AND**
- Not disqualified by law from voting in an election.

I further declare that I am entitled to vote by mail for the following reason(s) (**check at least one**):

- I have a physical disability, illness or injury that affects my ability to vote at another voting opportunity for this election; **AND/OR**
- I expect to be absent from the City at the times of all advance voting opportunities (October 10 and October 17, 2018) and on general voting day (October 20, 2018)

- c) I have been a resident of British Columbia for at least 6 months immediately before today;

- (1) Print applicant's surname and given names in full.
- (2) Print the street address or legal description of the applicant's real property in relation to which the applicant is registering. Applicant *must* attach satisfactory proof that he or she is entitled to register in relation to the real property referred to in part (2) of the application form (e.g., certificate of title, property tax notice, property assessment notice).
- (3) Print the applicant's mailing address including street number and name, city/town and postal code.
- (4) Print *either* the last 6 digits of the applicant's social insurance number *or* the applicant's birthdate. This information is required pursuant to the *Local Government Act*.
- (5) Complete this section if the applicant's name has changed since previously registering as a non-resident property elector.
- (6) Applicant must declare that he or she meets all the requirements listed in this section to register as a non-resident property elector.
- (7) Applicant must sign the application form in the presence of a witness.
- (8) The witness to the applicant's signature must sign the application form.
- (9) Print residential address of the witness. Not required if the witness is an election official.
- (10) You must attach the "Non-Resident Property Elector Consent Form" if the land title registration of the real property in relation to which a person is registering under this section indicates that there is more than one individual who is the registered owner of the real property. The person may only register as a non-resident property elector with the written consent of the number of those individuals who, together with the person registering, are a majority of those individuals.
- (11) If person is registering at the time of voting, 2 pieces of identification (at least one with a signature) to prove identity are required.
