PUBLIC HEARING NOTICE OPPORTUNITY FOR INPUT Zoning Bylaw Amendment

A Public Hearing will be held in the Council Chambers of City Hall, located at 301 St. Ann's Road in Campbell River, B.C., at 6:30 p.m. on Monday, July 25, 2016 to provide an opportunity for public input on Zoning Bylaw No. 3630, 2016.

What is the purpose of Zoning Amendment Bylaw No. 3630, 2016?
To amend Zoning Bylaw 3250, 2006 to add a definition of "Community Care Facility" and "Social Care Facility" to differentiate between the two uses and clearly identify where Social Care Facilities are permitted in the Commercial One (C-1) downtown zones.

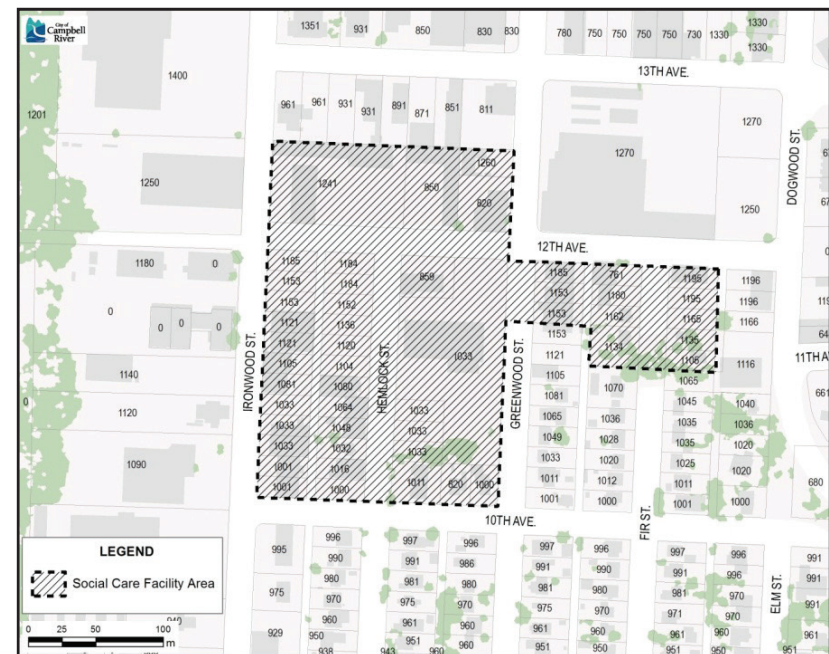
The following definitions will be added to Zoning Bylaw 3250, 2006:

- "COMMUNITY CARE FACILITY" means a facility licensed by the Provincial Government under the Community Care and Assisted Living Act as amended from time to time;
- "SOCIAL CARE FACILITY" means a use of a facility intended for the temporary care and shelter of homeless or under housed individuals for no fee or compensation and may also include facilities intended exclusively for the temporary care and the provision of addiction and mental health services as part or in support of emergency housing.

Further, this Bylaw proposes to add "Appendix 5: Social Care Facility Downtown Area" to the Zoning Bylaw 3250, 2006 to clearly show where Social Care Facilities are permitted in the downtown.

Where can I view a copy of the bylaw?

A copy of this proposed bylaw is available for public viewing at City Hall in the Community Planning & Development Services Department on regular business days between the hours of 8:30 a.m. and 4:30 p.m., Monday to Friday inclusive, from **Friday 15 July 2016 to Monday 25 July 2016**.



How can I provide comments?

You are able to speak at the Public Hearing or share a written submission for Council consideration. Written comments can be submitted in advance at City Hall in the Community Planning & Development Services Department, to be received no later than 4 p.m. on July 25, 2016. Register at the Public Hearing or in advance by calling 250-286-5700.

Please note that legal considerations prevent Council from receiving any representations or submissions after the close of the Public Hearing
