A Public Hearing will be held in the Council Chambers of City Hall located at 301 St. Ann's Road in Campbell River, B.C. at 6:30 p.m. on October 11, 2016, to provide an opportunity for public input on Bylaw No. 3639, 2016.

What is the purpose of Zoning Amendment Bylaw No. 3639, 2016?

To reflect the Federal Government's August 2016 decision regarding medical marijuana production and refine the definition of "Marijuana Operation" within Zoning Bylaw 3250, 2006 and add this use as a permitted use within certain zones in the City.


