A Public Hearing will be held in the Council Chambers of City Hall located at 301 St. Ann's Road in Campbell River, B.C. at 6:30 p.m. on Monday, June 19, 2017 to provide an opportunity for public input on Bylaw No. 3641, 2017.

What is the purpose of Zoning Amendment Bylaw No. 3641, 2017?

The subject property is currently split-zoned with R-1, RM-1 and PA-1 areas (see attached map). The purpose of this application is to adjust the boundaries between the R-1 and RM-1 zoned-areas of the parcel to give greater flexibility to the design and typology of future housing development.
