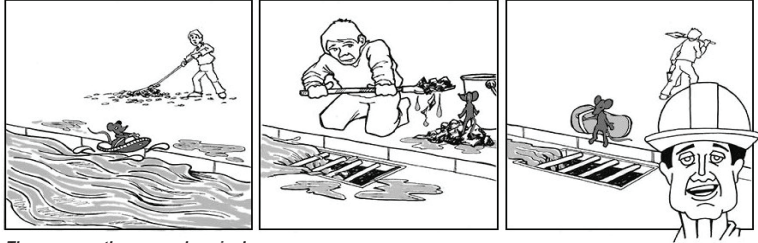

## Amendments to City's 2017-2026 Financial Plan to incorporate changes related to Council decisions this year

The City of Campbell River welcomes public input on amendments to the 2017-2026 Financial Plan that reflect decisions made by Council throughout 2017.

**The Community Charter requires the City to amend the budget bylaw with these changes and balance the budget prior to the adoption of next year's Financial Plan bylaw, which will be considered in December 2017.**

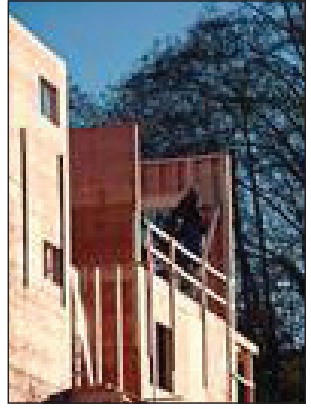
Once again, the City of Campbell River is hosting a Builders and Developers Forum; this month we will be joined by CMHC.
