## **READ CAREFULLY**

THE APPLICANT CERTIFIES that the applicant understands and will be guided by the provisions of Fireworks Regulation Bylaw No. 3297, 2007, as amended from time to time, and all applicable Provincial and Federal laws and regulations, in force from time to time, and any conditions or restrictions imposed in this permit by the Fire Chief.

THE APPLICANT FURTHER CERTIFIES that the applicant has reviewed and fully understands the attached Fireworks Safety Information Sheet.

THE APPLICANT FURTHER CERTIFIES that the applicant is authorized to the appropriate level by <u>Natural Resources Canada</u> to possess and fire, set off or explode fireworks of the class specified within this application.

IN CONSIDERATION of \$1 .OO and other good and valuable consideration (the receipt and sufficiency of which the applicant acknowledges), the applicant covenants that the applicant will indemnify and save harmless the City and its elected officials, employees, officers, agents and contractors from and against any and all manner of actions or causes of action, damages, costs, loss, or expenses of whatever kind (including, without limitation, legal fees) which the City or its elected officials, employees, officers, agents or contractors may sustain, incur, or be put to by reason of or arising out of:

- a) the issuance of this permit
- b) the consumer fireworks event or display fireworks event, including, without limitation, the handling, storage, discharging or other use of fireworks in connection with this permit;
- c) the applicant's use or occupation of the location upon which the consumer fireworks event or display fireworks event is to occur; or
- d) any act or omission of the applicant or any person for whom the applicant is at law, responsible, including, without limitation, the non-observance or non-performance of any obligation imposed by Federal or Provincial law.

The applicant acknowledges that he or she has had the opportunity to seek independent legal advice as to the contents of this agreement and that he or she is not under any legal disability.

PERMISSION IS GRANTED to the above applicant to discharge  $\Box$  consumer fireworks or  $\Box$  display fireworks (please check one), at the location and on the date and time(s) as set out above, subject to Fireworks Regulation Bylaw No. 3297, 2007, as amended from time to time, and to the following conditions and restrictions:

- This permit is not transferable. Only the applicant is authorized under this permit to discharge fireworks.
- The applicant may only discharge the type and quantity of fireworks described in the application.
- The applicant must ensure that all debris and litter related to a consumer fireworks event or display fireworks event that occurs on municipal property, including any litter left by the spectators, is removed from the location at the conclusion of the consumer fireworks event or display fireworks event.
- For a display fireworks event, in accordance with requirements of Fireworks Regulation Bylaw No. 3297, 2007, the applicant shall obtain a Comprehensive General Liability insurance policy with an inclusive limit of not less than \$5,000,000.00 per occurrence for bodily injury and property damage and provide evidence of the same to the Fire Chief no later than twenty-one (21) days prior to the permitted event.

# **Consumer Fireworks Safety**

Consumer Fireworks are not toys. Consumer Fireworks are, in fact, powerful pyrotechnic articles and, for this reason, both their sale and purchase are regulated. The Explosives Safety and Security Branch of Natural Resources Canada routinely tests fireworks and approves those that are safe to transport, store, handle, and use.

To ensure a fun but safe family fireworks display, it is important that the simple safety procedures outlined below are followed.



**PEOPLE UNDER 18 YEARS OLD** who use fireworks must be supervised by an adult.



**CHOOSE** a wide, clear site away from all obstacles. Refer to the safety instructions on the fireworks label for minimum distances from spectators.



DO NOT FIRE IN WINDY CONDITIONS.



**READ** all instructions on the fireworks. **PLAN** the order of firing before you begin.



**USE A GOOD FIRING BASE** such as a pail filled with earth or sand.



**BURY** fireworks that do not have a base **HALFWAY** in a container of earth or sand (such as a pail, box or wheelbarrow) unless the label on the firework indicates otherwise. Set them at a 10-degree angle, pointing away from people.



**NEVER** try to light a firework or hold a lit firework in your hand unless the manufacturer's instructions indicate that they are designed to be hand-held.




LIGHT CAREFULLY: Always light the fuse at its tip.



**KEEP WATER NEARBY**: Dispose of used fireworks (including debris) in a pail of water.







**KEEP** fireworks in a cool, dry, ventilated place, out of the reach of children.



IT IS RECOMMENDED that safety glasses be worn.
