A Local By-Election will be held on Saturday, FEBRUARY 27, 2021 to elect one Councillor for a term effective March 2021 to October 2022.

### QUALIFICATIONS

People qualified to be nominated, elected and to hold office as a member of Council meet the following criteria:

- Canadian citizen
- 18 years of age or older on general voting day [Feb. 27]
- Resident of British Columbia for at least six months immediately before the day nomination papers are filed
- Not disqualified by the Local Government Act or any other enactment from voting in an election in British Columbia or from being nominated for, being elected to, or holding office.

### NOMINATIONS WILL NOT BE ACCEPTED AFTER 4 P.M., FRIDAY, JAN. 22, 2021

Anyone unable to deliver nominations in person may mail them or have them delivered to City Hall or emailed to [elections@campbellriver.ca](mailto:elections@campbellriver.ca) (attention of the Chief Election Officer) by the Jan. 22, 2021 deadline. If sent by email, the original must be received by Jan. 29, 2021 at 4:30 p.m.

### CAMPAIGN and ADVERTISING EXPENSE LIMITS

For the local 2021 by-election, the Local Elections Campaign Financing Act stipulates:

- an expense limit of \$12,735.44 to run for Councillor during the campaign period, Jan. 30 to Feb. 27, 2021.
- directed third-party advertising expense limits to run for Councillor are \$1,264.20
- cumulative third-party advertising expense limit is \$150,000

**LIST OF REGISTERED ELECTORS** beginning Tuesday, Jan. 12, 2021, until the close of general voting for the Election, a copy of the list of registered electors will, upon signature, be available for public inspection at Campbell River City Hall between 8:30 a.m. and 4:30 p.m., Monday to Friday (excluding statutory holidays). An elector may request that their address or other information about them be omitted from or obscured on the list of electors.

**OBJECTION TO REGISTRATION OF AN ELECTOR:** An objection to the registration of a person whose name appears on the list of registered electors may be made in accordance with the Local Government Act until 4 p.m. Jan. 22, 2021. An objection must be in writing and may only be made by a person entitled to be registered as an elector in the City of Campbell River and can only be made on the basis that the person whose name appears has died or is not qualified to be registered as an elector of the City of Campbell River.
