Road Closure and Dedication Removal (Portion of Roadway Adjacent to 1890 19th Avenue)

Bylaw No. 3952, 2024

ADOPTED May 9, 2024

PURPOSE

Pursuant to the provisions in the *Community Charter* in relation to establishing and closing highways, Council may, by bylaw, close a highway, or a portion of it, to traffic and remove the dedication of a highway.

The Council of the City of Campbell River enacts as follows:

- 1. This bylaw may be cited for all purposes as "Road Closure and Dedication Removal Bylaw No. 3952, 2024." (Portion of Roadway Adjacent to 1890 19th Avenue)



- **2.1.** The Highway Dedication of the road dedicated by Plan 2474, District Lot 66, Sayward District, shown as Road to be Closed on Reference Plan EPP136474 marked as Schedule "A" attached hereto and forming part of this bylaw, is removed.
- **2.2.** This Bylaw shall take effect upon the adoption thereof.
