Campbell River's Most Unwanted – Knotweeds

Do you have knotweed on your property?

Knotweeds are among the top 10 invasive plants in B.C. They spread quickly threatening environmentally sensitive areas and their roots can damage foundations, driveways and roadways. The newly amended Environment Protection Bylaw restricts planting and requires removal of knotweeds on private property.

To tackle Bohemian, Giant, Himalayan and Japanese knotweeds:

- Report them to Lydia Stratemann at Greenways Land Trust via email to lydia@greenwaystrust.ca
- If on your property, inquire about the City's knotweed treatment program administered by Greenways Land Trust
- Most successful method of removal is chemical control applied through a certified pesticide applicator. This may require three to five years of treatment

How to dispose of knotweed

Remnants of knotweeds require careful handling. Compost or dispose of chemically treated plants through curbside yard waste collection or at the drop-off centre. Bag and take untreated cuttings to the Campbell River Waste Management Centre (landfill) at a reduced tipping fee (\$65 per metric tonne).

If you don't currently have knotweeds on your property, do (k)not plant them. Grow native and regional plants. Find alternatives in the Grow Me Instead booklet available on the Invasive Species Council of BC website.

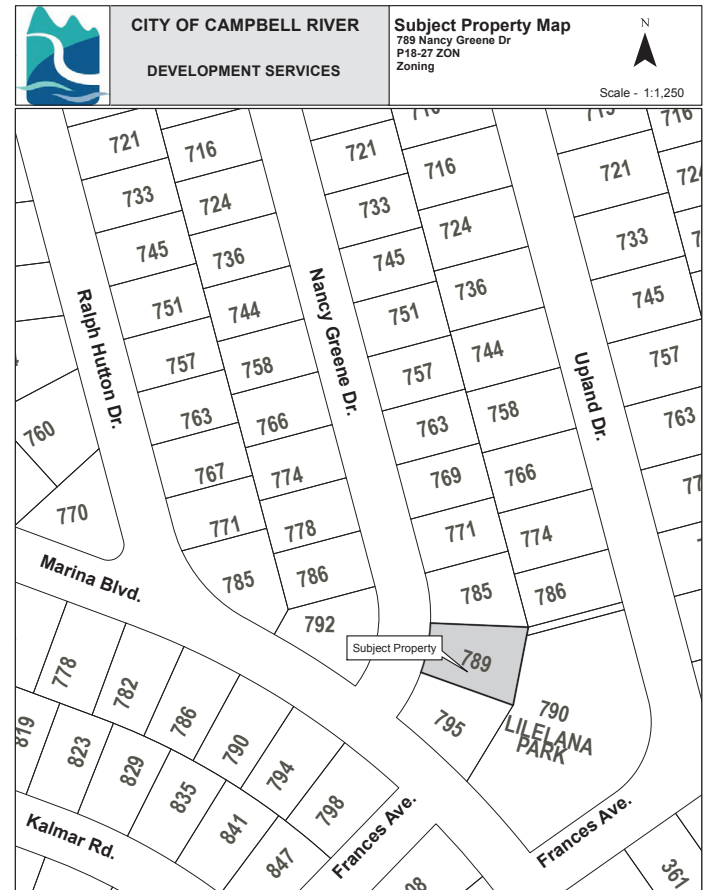
Where can I view a copy of the bylaw?
