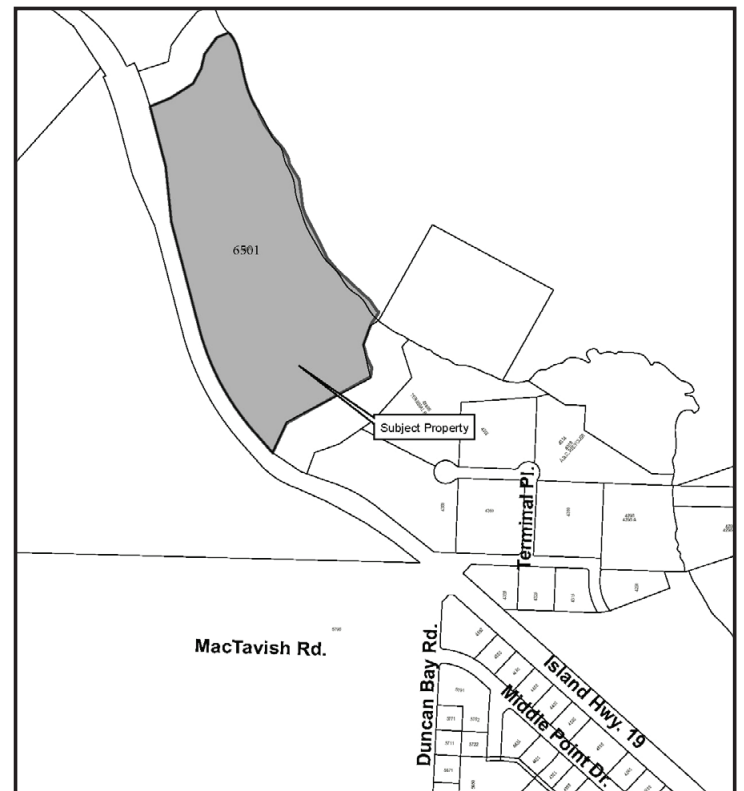

**What is the purpose of Zoning Amendment Bylaw No. 3691, 2018?**  
To add "Aquaculture Industry" as a use in the Industrial Two (I-2) zone to permit the development of an office and aquaculture operations on 6501 Island Highway.
