GENERAL VOTING DAY will be on Sat, Feb. 27, 2021 between 8 a.m. and 8 p.m. for qualified electors of the City of Campbell River at the Campbell River Sportsplex, 1800 South Alder Street.

RESIDENT ELECTORS MUST:

- be 18 years of age or older on voting day
- be a Canadian Citizen
- be a resident of BC for at least six months immediately preceding voting day (since Aug. 26, 2020)
- be a resident of the City of Campbell River for at least 30 days immediately preceding voting day (since Jan. 27, 2021)
- and not be disqualified by any enactment from voting in an election or be otherwise disqualified by law

RESIDENT ELECTORS who are not on the list of electors (voters list) will be required to provide two pieces of identification confirming identity and place of residence (one of which must contain your signature); or two pieces of identification confirming identity (one of which must contain your signature) and you will be required to make a solemn declaration as to your place of residence.

ACCEPTABLE IDENTIFICATION includes BC Drivers Licence, BC Identification Card, Social Insurance Card, Photo BC Services Card, Non-photo BC Services Card, Certificate of Indian Status as issued by the Government of Canada, Passport, BC Care Card or BC Gold Carecard, (the combined drivers licence and care card are considered one piece of identification), Credit Card, Debit Card, Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8, Vehicle Insurance, Birth Certificate, Citizenship Card, Statement of Employment Insurance Benefits, BC Government Cheque, Income Tax Assessment Notice, Canadian Forces Identification, Old Age Security Identification Card, Property Tax Notice or utility bill such as hydro, telephone, cable, showing residential address. Picture identification is not necessary.

NON RESIDENT ELECTORS MUST:

- be 18 years of age or older on voting day
- be a Canadian Citizen
- not be entitled to register as a Resident Elector of the City of Campbell River
- have been a BC resident for at least six months before election day (since Aug. 26, 2020)
- have been a registered owner of real property in the City of Campbell River at least 30 days immediately preceding election day (since Jan. 27, 2021)
- and not be disqualified by any enactment from voting in an election or be otherwise disqualified by law.
- If there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non resident property elector.

NON RESIDENT PROPERTY ELECTORS who are not on the List of Electors (Voter's List) will be required to fill out an application for registration by providing proof of ownership of the property (title certificate or current title search); two pieces of identification confirming identity (one of which must contain your signature); and a non resident property elector consent form of a majority of the registered owners, if there is more than one owner.

Non Resident Property Electors are encouraged to fill out the application and produce the required documentation at Campbell River City Hall, 301 St. Ann's Road, prior to 4:30 p.m. on Friday, Feb. 26, 2021 or by email to elections@campbellriver.ca

VOTER REGISTRATION: The City uses the provincial voters list from the provincial election. If you are not on the voters List, you may register by completing the required application form available at the voting place.

Any ballots received after this time will not be included in the count and marked as a spoiled ballot.
