#### DETAILS: A number of Zoning Bylaw Text Amendments are proposed, as follows:

- 1) In Section 4.1 (e), the "commercial bottling of groundwater" is added as a prohibited use;
- 2) In Section 5.15.2, "seafood processing" is added as a permitted use;
- In Section 5.15.1, "marine research laboratories and related facilities" is added as a permitted use;
- In Section 5.13.1, "coffee shop" and "restaurant" are added as permitted uses;
- 5) In Section 3.3, "Community Garden" is defined;
- 6) In Section 4.1, "Community Gardens" are added as a permitted use; and
- 7) In Sections 5.33.1 (a), (b) and (c), 5.34.1 (a), (b) and (c), 5.35.1 (a), (b) and (c) and 5.36.1 (a), the word "or" is removed, allowing a mix of multiple family housing typologies within the same development.

That means Monday collection will move to Tuesday, Tuesday to Wednesday and so on. Friday collection will move to Monday.


