## CITY TO PROVIDE ASSISTANCE BY PARTNERING AGREEMENTS

For 2023 Community Beautification Grants Program

City Council has approved in-principle three grants for area-specific beautification initiatives, public art, amenities and public space programming. This year's program will provide between \$10,000 in matching funds to the Campbellton Neighbourhood Association, and Willow Point Business Improvement Association, and \$19,862.86 to the Downtown Business Improvement Association. Improvements will include decorative lighting, murals, flower planters, waste receptacles, signage, and musicians.

The draft partnering agreements and records relating to the proposed assistance are available for public inspection, by email, or by appointment between 8:30 a.m. to 4:30 p.m., Monday through Friday, excluding holidays, at City Hall.

Council will consider the proposed partnering agreements on August, 17, 2023.

### MASTER TRANSPORTATION PLAN AND DOGWOOD CORRIDOR STUDY SURVEY

The City is updating its Master Transportation Plan (MTP) and recently shared the Draft Phase 2 MTP which includes priority projects for walking, cycling, taking transit, driving and parking/transportation demand management.

The Dogwood Corridor Study reviews Dogwood Street from the north end to the south end with recommendations to improve operations and safety. Both draft plans were presented to the public at the Open House, held on June 15, 2023. There is currently a survey available online, and in person at City Hall. The survey goes until July 21, 2023.
