# Woodstove Exchange Program

Rebate voucher forms available  
Expires April 30, 2015

The rebate program encourages you to exchange your old, uncertified stove for a new EPA or CSA emission certified wood, pellet, or gas heating appliance.

- 32 rebates are available on a first-come, first-served basis for City of Campbell River residents.



## AIR QUALITY

The goal of the rebate program is to help reduce neighbourhood wood smoke.

- Reduced smoke means reduced fine particulate air pollution — cited in a recent report by the Provincial Health Officer as the worst kind of air pollution in BC.
- Exposure to high levels of particulates can play a role in many kinds of respiratory diseases.

### Step 1: Qualify

In order to qualify, the appliance being exchanged must be presently used for heating purposes in your home and must be a non CSA / EPA certified stove built prior to November 1, 1994. Your retailer can assist you with confirming this step. Take a picture of the old stove, fireplace or wood burning furnace in use.

### Step 2: Tracking Number

Prior to purchasing a new appliance, call or email the City (see contact info on reverse) to receive a tracking number for your rebate voucher and to ensure rebate availability. The vouchers are available from the City and participating retailers (listed on reverse), but only the City can issue the tracking number.

### Step 3: Installation

Check with participating retailers to see if there are any additional manufacturer rebates available. The City will require a copy of the

appliance purchase receipt and a photo of the newly installed appliance.

### Step 4: WETT Inspection

If your wood stove replacement is a solid fuel burning appliance or insert, a copy of a WETT-certified technician's installation or inspection report of the stove and chimney assembly must be submitted with your rebate voucher. Talk to your retailer or phone Stewart Dumont, Fire Department at 250-286-6266 for more information.

### Step 5: Old Stove Disposal

Participating retailers will ensure that your old appliance is decommissioned and recycled. Please have them sign your voucher verifying this step was completed and have them take a picture of the decommissioned stove.

## REBATE CHECKLIST

- Completed voucher
- Photo of your old wood stove in use
- Copy of your new appliance purchase receipt and photo of your newly installed appliance
- Copy of the WETT-certified technician's installation or inspection report of the stove and chimney assembly
- Photo of the decommissioned old stove

## STEP 6: Collect Your Rebate!

Mail or drop off your completed voucher, photos and receipts (as per the rebate checklist) to the City of Campbell River (contact information on reverse). Please keep a copy of all paperwork for your own records. We will mail you your \$250 rebate and a customer appreciation package. All rebate vouchers expire April 30, 2015 and must be filled out and received by the City **no later than May 15, 2015.**
